

# TRUST DEED – EDUCATIONAL OR JUVENILE TRUST (EJ)

#### Please read these important notes before completing the Trust Deed

- While Prudential is prepared to assist you in effecting your policy under a trust, Prudential cannot accept any legal responsibility for the appropriateness of the trust or its wordings or the effectiveness of the trust or any other legal or tax consequences. If you have any doubts, you should consult a lawyer.
- The trustees must always comply with trust law and act in the best interests of the beneficiaries in carrying out the provisions of the trust.
- Prudential will make payment of the benefits jointly to all existing trustees, unless directed by them in writing to do otherwise.
- If no trustee is living when the policy money becomes payable, settlement cannot be made until it has been established from whom Prudential may correctly accept a discharge. It is therefore advisable when considering your choice of trustees to arrange, as best as possible, at least one trustee who is likely to outlive the life assured.
- If you opt for Juvenile Trust, the policy will cease to be a Trust policy when the life assured reaches age 21. Thereafter, the life assured will take over full legal and beneficial rights under the policy and Prudential will make payment of the benefits directly to the life assured.
- In the event that payments of premiums under the policy are not made (whether by the trustees or the life assured), the policy may lapse. In the event that the policy is lapsed, benefits under the policy may be lost.
- No amendments or corrections (e.g countersigning, correction tape, correction fluid) can be made on the form.



## **Declaration of Trust**

- I hereby declare myself, and I hereby further appoint the persons (if any) indicated below, as the trustees (which term shall include any trustee(s) for the time being hereof) of the above-named policy, all monies payable under it and any property for the time being representing the same or otherwise subject to these trusts, on the terms of this declaration of trust.
- New or additional trustees may be appointed by me during my lifetime. and by the trustees after my death, in each case by deed in the form required by Prudential. I, during my lifetime will also have the power to remove any trustee by deed in the form required by Prudential, provided that there shall always be a trustee remaining after any such removal. Any such changes must be notified to Prudential immediately.
- The trust hereby created is irrevocable. The trustees shall not take a loan under the policy, surrender or vary the policy, revoke or vary this trust or exercise any other rights or advantages under the policy without the express written consent of, or on behalf of, all the beneficiaries.
- If the trustees wish to exercise any such right with the consent of all the beneficiaries, they must do so for the absolute benefit of the beneficiaries, and if minor beneficiaries are involved, such exercise may be limited by law and must in any event comply with the Trustees Act (Cap. 337) and all other applicable laws.
- The trustees jointly have the power to give a valid discharge to Prudential of all liabilities under the policy.
- All premiums paid by me are for the sole benefit of the person(s) beneficially entitled under this trust, and I shall have no right by way of lien, charge or otherwise to reimbursement of any sum paid or provided by me as a premium on the policy the subject of this trust.
- This trust shall be governed by and construed in accordance with the laws of Singapore.

## Educational Trust
